## ABSTRACT

Abstracts for papers should be of approximately 300 words in length, with keywords, and should also include:

1. The title
2. The name, status and affiliation of the speakers (s),
3. A contact email address.
4. A template to assist for the abstract would be to ensure that each abstract has the following titles:
  - a. Purpose
  - b. Design / methods followed/ approach.
  - c. Findings.
  - d. Research limitations / implications.
  - e. Practical implications.
  - f. Originality / Value of work.

All conference rooms have a computer, data projector, and screen. Please also let us know if you require any special equipment.

Papers presentation shall **not exceed 15** minutes, followed by a period of Q & A.

Abstracts for papers (300 words maximum)	30 <sup>th</sup> September, 2019
Notification of acceptance of abstracts	15 <sup>th</sup> October, 2019
Submission of papers	5 <sup>th</sup> November, 2019
Notification to authors	8 <sup>th</sup> November, 2019

Authors should submit their abstracts electronically using MS Word format.

No papers will be included in the program until the presenter has registered and paid the relevant conference fees. This is necessary to ensure the quality of our programme.
